The Scope

The Paramedic Series include Fire Fighter II (Paramedic), Fire Captain (Paramedic), and Fire Apparatus Engineer (Paramedic). On top of responding to fire, incumbents render emergency medical assistance; performs cardiopulmonary resuscitation and electrical defibrillation; lifts and transports injured persons; administers intravenous saline, glucose and volume expanding agents; obtains blood for laboratory analysis; interprets cardiac arrhythmias; performs pulmonary ventilation by use of airway adjuncts; administers drugs; operates voice and biomedical telemetry communication systems and equipment; assists in childbirth; drives medical rescue vehicles under emergency conditions; prepares and presents to employees and the public demonstrations and classes in first aid, cardiopulmonary resuscitation and other subjects relating to medical assistance.

On The Job

Fire Fighter II (Paramedic) - Under supervision, (1) as a member of a fire apparatus crew, to perform the full range of fire-fighting duties in suppression of vehicle, building, improvement and vegetation fires; to assist in building, grounds, and equipment maintenance and repair; and (2) as a member of a paramedic team, to perform paramedic duties in emergency medical situations; and to do other related work.

Fire Apparatus Engineer (Paramedic) - Under general supervision, to operate fire apparatus during wildland and structural fire-fighting operations; to lead an assigned crew in the performance of fire-fighting duties; to maintain and make minor repairs on vehicles, equipment, and the fire stations; to perform fire prevention tasks; as part of a paramedic team, to perform paramedic duties in emergency medical situations; and to do other related work.

Fire Captain (Paramedic) - Under direction, to supervise the work of an engine company(s) and hand crew(s); with other Fire Captains, share in the management of a fire station, including the maintenance of emergency apparatus and equipment; to perform paramedic duties and supervise a crew of personnel engaged in emergency medical rescue activities; or to serve as paramedic coordinator in a ranger unit; and to do other related work.
