On The Job

State Fire Marshal Trainee - Incumbents in this classification, under close supervision, either learn fire behavior, building construction and fire prevention, fire scene and criminal investigation, or fire training methods, regulations, statutes, and codes related to the Office of the State Fire Marshal; observe and/or assist in fire and life safety inspections, fire scenes investigation and developing fire training courses; and attend assigned instructional courses.

Deputy State Fire Marshal - Conducts detailed building and fire safety inspections; recommends the proper design and installation of fire protection equipment; enforces fire safety standards in the construction, operation, and maintenance of various types of occupancies as specified in Title 19 and 24 of the California Administrative Code, other related codes.

Deputy State Fire Marshal III (Specialist) - Under general direction to administer the laws and regulations of the State Fire Marshal and to be a staff specialist responsible for a specialized fire prevention function; and do other related work.

Deputy State Fire Marshal III (Supervisor) - Under general supervision, either (1) supervises the field enforcement and office staff within a portion of a large geographical region of the State; or (2) supervises a highly specialized, technical enforcement program; and does other related work. Through subordinate staff, incumbents in this classification administer the laws and regulations of the State Fire Marshal.
